Prevention/Mitigation

WSD has the following items in place for the prevention and mitigation of emergencies:

- 1. Comprehensive All Hazards Plan
- 2. District Wide Safety Committees
- Partnerships with local police departments
- 4. Board Policies (including but not limited to the following):

Preparedness

WSD has numerous systems developed to help prepare the students and staff for emergencies:

- 1. A monthly drill at each building for one of the following;
 - Fire
 - Severe Weather
 - Lockdown
 - Evacuation
 - Reverse Evacuation

Preparedness (Continued)

- 2. WSD Policy #805 Emergency Preparedness
- 3. Annual functional drills
- 4. AlertNow Rapid Communication System:
 - Automatic calling system that we
 utilize to send out voice calls, email
 messages or SMS messages. This is
 used for daily items like attendance, as
 well as emergency messages.



- 5. Crisis Response Teams:
 - Faculty/staff that are Crisis Prevention and Intervention (CPI) trained at each building

Response

The response portion of our All Hazards Plan includes action steps to be implemented when an incident occurs.

These lists were developed based on guidance offered from PEMA and through consultation with a safety and security specialist at the IU13 and local law enforcement agencies.

Recovery

The recovery portion of the safety plan refers to the decisions and actions that occur after an incident to restore and/or improve upon pre-incident conditions of the impacted facility and its community. Recovery efforts also include taking into account the physical, emotional, and psychological well-being of all participants.

An important part of the recovery process is parent and student reunification. Staff, students, and parents must all be aware of their responsibilities so this can be done in a timely fashion. The Warwick School District has Memorandum of Understandings with established evacuation sites for each school, with detailed plans and maps for the evacuation process as well as the parent-student reunification process. Preplanning for both processes is essential for meaningful recovery to occur.
